Minutes: SJSU ERFA Executive Board Monday, February 5, 2018

1. Call to order: The meeting was called to order by President Ji-Mei at 10:01:10 Pacific Standard Time (PST).

2. The Minutes of the December 4 board meeting were amended by Dennis to correct a misspelling of Carmen's last name and approved by voice vote

3. President's Remarks

A. Celia has volunteered to monitor the speaker list during deliberations.

B. The provost office made a query about continuing the president's reception this year for fully retiring faculty and those starting FERP, and ERFA has responded with an affirmative answer. The date is to be determined.

4. Upcoming Events and Activities

A. Spring Excursion. Carmen, on behalf of the program committee, distributed handouts via email before the meeting about five possible venues. The San Francisco Museum of Modern Art (SFMOMA) as well as the Oakland Museum was seriously considered, but there was support for something "different" terms of a visit to Moss Landing Marine Laboratories and the Elkhorn Slough. A spirited discussion followed about the pros and cons of each venue (including Dali17 Museum and the DeYoung Museum, but the consensus was for Moss Landing and the Elkhorn Slough. Motion by Lonna, seconded by Joan, was approved with three abstains. In further action, the second week of April was preferred, and that the program committee would work out the details and costs.

B. Spring Luncheon and Business Meeting. Carmen, on behalf of the program committee, distributed a selection of possible speakers and performing groups for the May 11 meeting. After a spirited discussion, the consensus was in favor of having "entertainment" instead of a speaker. Bob moved, Nancie seconded, for having a singing group or something similar. Motion was approved with 14 with one opposed and one abstain. Lonna then moved, Jo Bell second that Larry Hancock and Opera San Jose be contacted to provide the program. Motion passed unanimously

5. Action Items

A. Slate of Officers for 2018-19. The nominations committee submitted a slate of proposed officers for 2018-19. The slate is Elba Maldonado-Colon, president; Christian Jochim, vice president; Dennis Wilcox, secretary (2nd year); Abdel El-Shaieb (1st year); Peter Buzanski, faculty senate (one-year-term); and members at large: Carmen Sigler (1st year); Bill McCraw (2nd year); and Jo Bell Whitlatch (2nd year). Ji-Mei Chang becomes past president. Peter moved, Wayne seconded, that the committee's report be accepted. The motion was approved with one abstain. There will also be a call for nominations in the newsletter and from the floor at the May 11 business meeting.

B. Promoting CSU-ERFA membership. Jo Bell distributed a draft of a statement encouraging SJSU-ERFA members to join CSU-ERFA that would be published in the May newsletter; the statement will also suggest that SJSU-ERFA members should consider payroll deduction in their pension checks for local membership. Bob, in the discussion, said that the newsletter article should include – for full transparency – that there are monthly CSU-ERFA dues for members. Jo Bell moved, Peter seconded to encourage SJSU-ERFA members to join CSU-ERFA. Motion passed with one abstain.

C. Finalists for ERFA Faculty Research and Creativity Awards. Joan reported that the review committee recommends this year's recipients be Dr. Ruma Chopra (Dept. of History) and Professor Alan Soldofsky (Dept. of English) whose research proposal summaries were distributed in a handout to the board. They were chosen from 25 applications. Joan moved, Nancie seconded, to accept the committee's recommendation. The vote was unanimous. The committee then recommended that Dr. Ninghun Wang, assistant professor in the Department of Chemistry be given a third grant, which was a departure from just naming two awardees. Abdel indicated that there would be sufficient funds this year to cover a third grant, but such action should not be considered a precedent for future years.

By voice vote, the board approved the third grant with one "no" from Bob who expressed the opinion that the committee should also consider applications from ERFA members. Dolores expressed the opinion that the two awardees this year are full professors (the third is an assistant professor) and thought that assistant and associate professors should be given more consideration to fund their research for tenure and promotion. The committee responded that it was a hard choice, but the two full professors had the best proposals in this year's competition.

D. Biographies Committee. Joan made the motion that the biographies committee proceed with the biographies project in collaboration with the University library on Scholarworks. Peter seconded. Lonna expressed opposition to the motion saying that posting of personal faculty information would be an invasion of privacy. Others expressed the thought that such information is already widely available on the Internet through Google and that participation in the Scholarworks project was voluntary. Members of the biographies committee said they would work with the library to determine what information would be posted on Scholarworks. The board voted, with three abstains, to proceed to work with the library on the project. The

committee, in future meetings, will make further recommendations about implementation of the biographies project.

E. Center for Faculty Development/ERFA Research Project. Joan, on behalf of the Center for Faculty Development (CFD) proposed that SJSU-ERFA collaborate on a research study about retiring faculty and how they perceive the transformation from full-time teaching to retirement. CFD already has a data set and a list of questions approved by the Institutional Research Board (IRB) and would like to use the current ERFA directory to identify members who FERPed between 2007 and 2012. Joan said there are 62 members in that category and she would work with Amy Strage at CFD to send an email to these members asking if they would be willing to participate in a survey conducted via face-to-face, skype, or even by email. The motion to allow CFD access to the SJSU-ERFA directory was made by Dennis and seconded by Jo Bell. The motion passed with two members abstaining.

6. Discussion Items

A. Update on Fall Luncheon. Lonna reported that Café Stritch on South First Street has submitted a bid for \$30 per person that includes service charge and sales tax. Lonna moved to accept the proposal, Nancie seconded, and the vote to approve was unanimous. The lunch will be **Friday, Oct. 26th**. In addition, Lonna announced that the holiday party will be Friday, December 7th.

7. Reports

A. Treasurer. Abdel reported a balance of \$10,098.76 and 202 paid members.

B. Membership. Wayne reported receipt of a new member application and there were now 297 members on his roster, including individuals who had not yet paid their dues.

C. Newsletter Editor. Gene reported that the newsletter would be done in mid-February. He also arranged for the printing of 250 more note cards, primarily used for consolations.

D. Webmaster. Carol reported “everything up to date.”

E. Consolations. Jill reported consolations were sent to the family of Mary Bowman, Dimitri Thoro, and the son of Kate Sullivan, a current member of the faculty who died in January.

F. Film group. Don reported that the group recently viewed “Molly’s Game.”

G. Faculty Senate. Peter reported that the faculty and students are somewhat upset with the president’s decision to hold graduation ceremonies in May for each college at the Events Center or Avaya Stadium instead of having a general university commencement at Spartan Stadium, which apparently is unavailable. There is also concern that the Office of Advancement is now in charge of commencement instead of the “academic” side of the house.

H. CSU-ERFA. Bob reported that the state meeting will be in April. Unofficial reports indicate that the CSU-ERFA proposal to include “staff” in state membership passed with a small number of CSU-ERFA members actually participating in the vote.

8. New Business.

A. Multiple University Graduation Ceremonies. This item was postponed to the March meeting when the board will discuss how to represent ERFA at multiple graduation ceremonies. Also, see comments by Peter in the Faculty Senate Report.
