Theme and Goals of Conference

The single most important goal guiding the creation of the National Association for Chicano Studies was to promote research and other activities that could contribute and respond to the struggles being carried out in the broader Chicano community. This premise is clearly embodied in the Association's Preamble which states that NACS arose "to encourage a type of research which it felt could play a key part in the political actualization of the total Chicano community" and calls for research that is "committed, critical and rigorous." However, most of us in Chicano Studies work in institutional settings that present serious obstacles to the realization of this objective. And there are few arenas for studying, discussing and debating how best to promote this vision. Thus this year's site committee has decided to make this issue the major focus of the 1989 NACS national conference. The theme is *Community Empowerment and Chicano Scholarship: Towards Social Justice in the 21st Century* and we are calling for panels, papers and roundtables that generally address this concern. While we want to emphasize this issue, the conference format is such that we also want to encourage proposals on other topics. The site committee is also making an effort this year to incorporate representatives from the professions, particularly in the areas of education, law, planning, community organizing and health.

Call for Proposals to Establish a NACS National Office

The NACS national body approved at the 1988 annual meetings, the establishment of a national office. Proposals are now being solicited from regions wishing to house the national office.

The guidelines for such proposals follow are:

- › The national office shall be attached to a Chicano Studies program, academic department, research center, or similar unit.
- › The national office will be administered by an office manager who will keep the office open a minimum of 20 hours per week each normal working week of the academic year.
- › The purpose and responsibilities shall be to promote the goals of the association and include but are not restricted to the following:
 - a) maintain the NACS membership list
 - b) develop and implement an on-going membership drive
 - c) prepare and distribute the NACS newsletter
 - d) receive and distribute the NACS proceedings
 - e) assist the NACS coordinating, site, editorial and any ad ho committees as needed
 - f) prepare and distribute a NACS brochure
- › The national office will report directly to the Coordinating Committee and will provide semi-annual reports to that body. Routine supervision of the office will be the responsibility of the General Coordinator of the Coordinating Committee in conjunction with a local NACS member to be proposed by the host institution and approved by the Coordinating Committee.

- › The Coordinating Committee will conduct a thorough review of the national office at least every three years.
- › The Coordinating Committee will reserve the right to propose to the membership that the site of the national office be relocated should the need arise.
- › Proposals should cover a minimum of a three year period.
- › The Coordinating Committee will review each proposal and make a recommendation to the membership which will make the final decision.
- › Upon selection of a national office site, the Coordinating Committee will appoint an ad hoc committee to develop a fund raising plan to establish an endowment for the office.

General Guidelines for Proposals to Host the NACS National Conferences

Any and all proposals submitted to the National Association for Chicano Studies (NACS) should meet the following criteria. The proposals will be considered by the NACS Coordinating Committee and then be submitted to a vote of the Association's membership at the annual business meeting.

The proposal to sponsor the annual meeting should indicate in writing the willingness and commitment of the institution(s) and/or community organization(s) to undertake said task. This letter must come from the program, department, agency or institution which is accepting responsibility for planning, organizing, coordinating and conducting the conference. While great latitude is afforded in planning, organizing, coordinating, financing and conducting the conference, the site committee must recognize, accept and be bound by the NACS constitution, by laws and policy. The local site committee can expect the full cooperation of the NACS coordinating committee. The local site committee and conference coordinator are responsible for generating and meeting all conference expenses. Very limited financial support is offered by NACS.

All proposals should be sent to the current chairperson of the NACS Coordinating Committee.

The letter requesting sponsorship of the site should indicate the following:

- › The university or community organization's interest and commitment to holding the conference with appropriate letters of support from institutional officials such as the President, Dean, Board of Directors, etc.
- › The ability to plan, organize, coordinate, finance and conduct said conference. This includes faculty, staff, graduate and undergraduate students to be involved or who have expressed willingness to work with the local site planning committee. (Focos, local faculty, student and community organizations, etc.)
- › The site committee should briefly describe the feasibility of housing and travel accommodations. Access, cost and scheduling details should be adequately discussed.
- › The ability to finance the sponsorship of annual meeting. Past conference sites have obtained letters from appropriate officials offering tentative support. The budget should include the costs of facilities, printing, mailing, supportive services, etc. It is suggested that one speak to past conference coordinators concerning the costs entailed in sponsoring the national conference.
- › Also to be addressed should be points of interest concerning the site (which highlight the positive, unique, etc.) and any other factors that may be deemed important.
- › As closely as possible include the dates and description of facilities to be used and their proximity to housing, airports and related activities important to the proposed conference.
- › All proposals, as well as any questions related to these guidelines should be directed to the General Coordinator Tacho Mindiola Jr.
- › The deadline for submitting completed proposals will be announced far enough in advance to give ample opportunity for person(s) or organization(s) wishing to submit such a proposal.

Nomination for NACS Scholar

Nominations are being accepted for the NACS Scholar. The NACS Scholar should be an individual who has made a significant scholarly contribution to Chicano Studies. According to the NACS bylaws, the specific criteria to be used in recognizing a scholar are as follows:

- › a scholar's personal history of involvement in the development of Chicano Studies literature or as a discipline; and
- › his/her significant contributions to scholarly research and writing on the Mexican population in the United States.

Nominations for such an award should come from individual Focos or the Conference Site Committee. Such nominations should include an explanation of the appropriateness of such recognition. The person selected as the NACS Scholar will be recognized as such at the 1989 NACS Conference in Los Angeles, California. The Association will defray the scholar's expenses to attend the conference. The scholar shall be made a life-time member of the Association with all the rights, privileges and responsibilities of a member. The scholar will be invited to address the NACS membership at the conference on a topic of his or her choice. Nominations should be sent to the NACS General Coordinator, Tacho Miniola Jr., no later than January 15, 1989.

NACS Student Premio Competition

The National Association for Chicano Studies announces its annual Frederick Cervantez Undergraduate and Graduate Student Premio Competition. A one hundred fifty dollar prize plus consideration for publication in the annual conference proceedings are awarded to the best undergraduate and graduate student papers. Papers will be judged on originality, content, and mechanics.

Competition Requirements:

- › Participants must be enrolled at an institution of higher education and be members of NACS. To join the association write to Professor Ramon Chacon, Department of History, Santa Clara University, Santa Clara, CA 95119.
- › All papers must focus on a Chicano Studies topic and seek to contribute to the development of Chicano Studies as an interdisciplinary area of study.
- › Three copies of each paper are required. Papers should follow well-accepted guidelines of term papers, and should be fully referenced, typed and double spaced. Papers should be 12 to 25 pages in length.
- › Each paper should have a title page with full name, address, institutional affiliation and telephone number. Each paper should be clearly marked GRADUATE OR UNDERGRADUATE. Lack of clear identification of competition category will disqualify the paper from the competition.
- › The title should appear on the title page and again on the first page of the paper. The author's name should not be repeated on the first page.

- › Papers should be postmarked no later than *February 1, 1989. Late papers will not be accepted.*
- › Students are encouraged to present their papers at the NACS XVII Annual Conference, March 29-April 1, 1989, Biltmore Hotel, Los Angeles, CA.

Midwest Regional Conference

The Midwest Regional Foco held a successful conference at the University of Illinois at Chicago Circle on October 14th and 15th. The title of the meetings was *Sin Fronteras: Reclaiming Our Past To Forge Our Communities Future* and focused on bringing academics and community activists together to address a broad spectrum of policy related and cultural issues. The site committee chair, Teresa Cordova Acosta from UIC, spearheaded the effort and we congratulate her efforts to promote NACS. We also want to congratulate her and her husband Miguel on the birth of their son, Jose Miguel Acosta two weeks prior to the meetings. As Teresa indicated throughout the conference, its success was the result of a collective effort by members of the site committee and affiliates, which included faculty, staff and students from UIC, as well as representatives from community organizations such as Latino Youth, Instituto del Progreso Latino, Casa Aztlan, and Mujeres Latinas en Accion.

Somewhere between 250 and 300 people attended the meetings and came from throughout the Midwest, including strong representation from Minnesota, Nebraska, Wisconsin, and Michigan. There were also people from as far as Massachusetts, Colorado and California who participated as well. Conference highlights included a keynote address by historian-activist Rudy Acuna from Chicano Studies at Cal State, Northridge who reviewed some of the problems encountered in trying to link Chicano Studies in the university to community issues and struggles. Bert Corona, from Hermandad Mexicana Nacional, delivered a keynote address reviewing his fifty years of activism and was presented with an award for his many contributions to organizing in the Chicano community.

The NACS Northern California Region will hold its 8th annual conference beginning at 9:00 am, Saturday, December 3rd, at California State University, Sacramento. Duties: The appointee will be expected to (1) establish a nationally recognized program of empirical research, (2) develop and teach undergraduate and graduate courses, (3) supervise the research of graduate students, (4) teach and provide intellectual leadership in a professional program of teacher preparation, and (5) participate in department and university activities and public service. Salary will be commensurate with experience and qualifications.
