#### Executive Board Meeting

Monday, March 2, 2015

10:00 to 11:30 a.m. --- Duncan Hall 249

**Members Present:** Gene Bernardini, Peter Buzanski, Jill Cody, Barbara Conroy, Adnan Daoud, Abdel El-Shaieb, Dolores Escobar-Hamilton, Don Keesey, Bill McCraw, Joan Merdinger, Wayne Savage, Carmen Sigler, Lonna Smith, Jo Bell Whitlatch, Bob Wilson, Marian Yoder.

1. **Call to order.** President Merdinger called the meeting to order at 10:02 a.m.
2. **Approval of *Minutes of February 2, 2015.*** Buzanski/Bernardini moved to approve minutes as presented, with one change in 6. h. "directions" to "directives".
3. **President's Remarks.** Joan noted we had some urgent issues related to Spring Excursion.
4. **Upcoming Events and Activities**
  - a. **Spring Excursion – March 27, 2015**
    - i. ***Walt Disney Museum - details for the day/Gene Bernardini, Jill Cody & Activities Committee.*** Jill needs someone to be the coordinator the day of the Event as she will be at a conference in Los Angeles. Don Keesey volunteered to be the coordinator for the day. Flyer has the wrong price and wrong deadline and must be corrected. Gene will contact the mailroom to stop the flyer before it gets distributed. Flyer has gone out on email: Carol will be asked to send out revised information this evening.
  - b. **Spring Luncheon: May 8, 2015**
    - i. ***The Villages – details for the day/Dolores Escobar-Hamilton, et al.*** Draft menu was distributed. Lonna proposed that the choice be: Chicken Breast, Beef Stroganoff, and Vegetable Quiche with Peach Pie. Bob Wilson proposed Sole instead of Chicken Breast. Lonna accepted the Sole as a friendly amendment. Bob Wilson seconded. Motion passed. Peter moved to charge \$27.00. Bob Wilson seconded. Motion passed with two members voting "no." The Provost has accepted our invitation to speak at the Spring Luncheon, but now may be unable to attend (he may be in China). Gene/Bob made a motion that we no longer pursue the Provost as our speaker and pursue alternatives with a small committee. Bob called the Question. Motion carried. Peter/Jo moved to rescind the motion. Question called. Motion rescinded with two opposed. Carmen/Dolores moved that we approach the Provost and request from him a firm commitment by April 6. Abdel proposed an amendment, which was accepted as friendly: Joan, Peter and Carmen will form the small committee to deal with this issue. Motion passed.

- g. **Activities Committee (Marian Yoder/ Don Keesey).** Yesterday, eight people saw Leviathan, a satire on Russian life, which was very interesting.
- h. **Faculty Senate Report (Peter Buzanski).** Report is basically in the *ERFA Newsletter*. Additions to the *Newsletter* content are: first, the German major is in the process of being abolished. The University requirement of having 20 students in an upper division class is related to the abolishment. Second, a new proposal concerning the library is of concern. Senator Ken Peter has made a long analysis, which Peter will forward to the Secretary for distribution.
